#### 23/13 Public Session

Matters arising from the public session:

- Discussion took place regarding the anti social behaviour on the Skate park it was agreed to agenda this for the next meeting
- District Councillor Mrs Sutton mentioned the B.D.C match funding scheme
- County Councillor Mrs Yates confirmed that the old school site has been sold and she
  is currently waiting for further information. It was agreed to send a letter to the Chief
  Executive at N.C.C and ask for an explanation of the process they went through when
  selling the property
- The faulty interactive lorry sign has been reported
- The 40mph sign for Smeath Lane may be possible next year
- A traffic survey has been carried carried on the A620 and does not meet the require figures for the introduction of a pedestrian crossing; one if the residents is currently obtaining further signatures for the petition

9/13 Cllr Yates reported that a separate notice of work has been issued for the work on Clarborough Hill. Work has been carried out on the subsiding grids. The Chairman rang B.T and a new manhole cover is to be put in. The grass cutting on Big Lane has been carried out by N.C.C.

#### 29/13 To report/update any Highways/rights of way issues

- Overgrown hedge at Howbeck House and the footpath on Howbeck Lane is not accessible due to overgrown vegetation Chairman and Cllr Collins to check out
- Little Lane- overgrown hedges
- Overgrown hedges on Chapel Close; the Clerk has reported and work is to be carried out
- The interactive sign for Little Gringley Lane has been given the go ahead, the 30mph will be moved back and the interactive sign put in its place

### 30/13 To receive reports on Play Areas

Cllr B Codling reported that the goal mouth area on the junior football pitch will require some attention in the future; all other equipment is okay.

The skate park inspection was okay just some small twigs and branches that require clearing. Cllr Codling has put some screws in the ramp. Litter is still a problem but improving.

Cllr Collins commented that the football pitch was no good for practising and that the goal posts should be moved out to make a full sized pitch; the Chairman mentioned that the reason for the size of the pitch was due to the possibility of a footpath in the future.

The Chairman commented on the BDC match funding scheme; the deadline is 31<sup>st</sup> August so if the Councillors had a think and discuss any ideas before the deadline.

Cllr Grice met with Johnny Davis one of the Senior Highways Officer to discuss varies highways issues in the parishes. An action report has been emailed to the Clerk.
